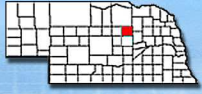

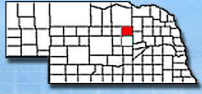

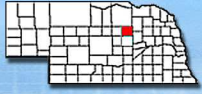

Snider presented the loader bids that were received. After reviewing Plugge made a motion to accept the bid for the Case 721 F loader for the price of \$157,987.00, seconded by Landgren. On roll call by the Clerk voting aye: Plugge, Landgren, and Poulsen. Voting nay: none.

Snider presented a Road Crossing Permit application for Jamie Rudolph to run electrical wire from the intersection of 505th Ave and Old Highway 101 and ¼ mile west, in Section 18 Township 21 Range 9 and a Road Crossing Permit application for Rick Funk to replace the old electrical wire in the Northeast quarter Section 1 Township 23 Range 9. Landgren made a motion to approve the Road Crossing Permits, seconded by Poulsen. On roll call by the Clerk voting aye: Landgren, Poulsen, and Plugge. Voting nay: none.

Poulsen made a motion to appoint David Durre as an alternative Zoning Member, seconded by Plugge. On roll call by the Clerk voting aye: Poulsen, Plugge, and Landgren. Voting nay: none.

Snider presented two contracts from Tonniges & Associates, for the upcoming year's audit, one for a one year contract and the second for a two year contract. Poulsen made a motion to accept the one year contract for the 2015-2016 Audit, seconded by Plugge. On roll call by the Clerk voting aye: Poulsen, Plugge, and Landgren. Voting aye: none.

Plugge made a motion to modify the Employee Hand Book to close the Courthouse on Christmas Eve and to require 24 hours' notice for an employee to take time off. Seconded by Landgren. On roll call by the Clerk voting aye: Plugge, Landgren, and Poulsen. Voting nay: none.

Poulsen made a motion to adopt Resolution 01112015, regarding the LEOP, seconded by Landgren. Voting aye: Poulsen, Landgren, and Plugge. Voting nay: none.
